REVIEW OF BUILDING REGULATIONS

Since the spring, many residents have been asking questions about the impact of revisions to provincial building regulations. Here's a quick look at how the changes may affect you:

Building vs. development permits

A **building permit** is required for all work on buildings that are subject to the *National Building Code of Canada*, and all buildings over 56.08 m² (603.65 ft²). This includes the construction of new buildings and the alteration, renovation, reconstruction, demolition, removal and relocation of existing buildings.

A **development permit** is required for all work on buildings or structures less than 56.08 m² (603.65 ft²), accessory structures not intended for accommodations, and for the placement of mini-homes and mobile homes on non-permanent foundations.

Q&A

Q. Can I use (unstamped) lumber from a sawmill to build my camp?

A. Yes, as long as it's less than 56.08 m² (603.65 ft²) and in a rural area. Municipalities may have bylaws in place that override provincial regulations.

Q. So, I don't need a permit for a 55.8 m²-camp (600 ft²)?

A. Not exactly. You still need a development permit. Your building still has to meet several requirements under the Community Planning Act, such as road setbacks and land use regulations.

Q. I'm still not sure I understand. Who can I call for more information?

Emergency preparedness starts at home!

Every disaster is a local disaster. If an emergency occurs in your community, you won't be the only one needing help. It may take some time for rescue workers to arrive, and you may not have access to a warming centre or shelter for several hours.

You must be prepared to take care of yourself and your family for at least 72 hours in the event of an emergency. Understand the risks in your area, create an emergency plan for your home, and prepare an emergency kit.

WHY WAIT?

Bulky waste collection is a special collection for large items, not for large quantities of waste.

Here are some alternatives for getting rid of many items year-round rather than waiting:



Does it fit in a bag?

If your item is smaller than a backpack and not too heavy, then all you need to do is put it in the right bag!

All of these items can be put in a blue or clear bag year-round:



Renovating?

Plan ahead to keep construction and demolition (C/D) waste disposal fees to a minimum. **The solid waste department collects only small quantities of C/D waste:**

- For very small reno projects, we accept **one clear bag** of C/D waste every two weeks (during clear bag collection week).

For small projects:

- Use the residential bulky waste collection service (limit of 5 bundles per residence).
- Haul the equivalent of half a ton of material to one of our mobile eco-depots (see page 9 for the schedule).

For larger projects:

- Hire a collection service from a private company or rent a dumpster.
- Haul the material yourself to the Southeast Eco360 landfill site at 100 Bill Slater Drive, Berry Mills, NB, E1G 3S2.

MOBILE ECO-DEPOTS 2021

The Kent Regional Service Commission is proud to announce the return of Eco-Depots. Offered in partnership with Southeast Eco360, this **FREE** service allows you to dispose of bulky, hazardous and other types of waste at a location near you.

✓ THE FOLLOWING ITEMS ARE ACCEPTED:

Maximum quantity equivalent to a half-ton truck or utility trailer load. Residents are asked to sort their load by type of material to facilitate unloading.

- Appliances and furniture
- Construction and demolition waste (make sure it's easy and safe to transport)
- Hazardous household waste
- Small motorized tools (must be emptied of oil and gasoline)
- Wood pallets (limit of 5 per resident)
- Marine debris (limit of 5 traps and 10 buoys per resident)
- Glass (the glass gathered during these collections will be recycled);
- Tires (limit of 8 per resident)
- Ash
- And more!

✗ THE FOLLOWING ITEMS ARE NOT ACCEPTED:

- Auto parts (except tires)
- Regular waste eligible for roadside pick-up (blue, green and clear bags)
- Bulk waste not sorted by type of material
- Commercial waste

IS YOUR WASTE SAFE?

Your waste is handled by several people, both at the time of collection and afterwards during sorting. Help us keep these individuals safe!



Bags must be:

- Tied shut
- Easy to access
- Grouped together based on colour, as much as possible



Bins should be:

- Free of pests (wasps, mice, raccoons, etc.)
- Not too deep (bags should be easy to retrieve)
- Free of snow and ice both on and around



Sharp objects

- Items like broken glass or knives should be wrapped in paper, or put in a container, before being placed in a bag

✗ NEVER PUT THE FOLLOWING IN YOUR REGULAR TRASH:

- Needles
- Animal carcasses
- Propane tanks
- Compact fluorescent bulbs
- Paint
- Batteries
- Chemical products



The website is easy to navigate and contains a wealth of information on the Kent region.


