a. Strategic Planning

A revised copy of the action plan is circulated to the members and Paul Lang makes a few comments.

b. History Project (Mathieu Wade)

Mathieu Wade gives us a short presentation on the progress of the historical project. He explains that the project has taken a little delay due to unforeseen parental leave as well as the Covid19. He does a quick overview of the research that has been done and what remains to be done. The book is currently in its final stages. He should have something to give us at the end of 2020 or the beginning of 2021. One wish would be that the book could also be used in schools as a resource that could be useful as educational material with the website.

c. Bylaw Enforcement (Jordan Nowlan)

In his presentation, Jordan Nowlan, Bylaw Enforcement Officer and Development Officer of KRSC, says they have been very busy since arriving, even during a pandemic. He explains to the group that they act as a Bylaw Enforcement Officer in the municipalities and as a Development Officer in the LSDs. As a Bylaw Enforcement Officer, they check dangerous and unsightly properties, animal control, zoning violations, recreational fires and various complaints. As a Development Officer, they ensure construction and permit compliance. Jordan says they have a very good relationship with the Maxime Babineau, RCMP, and his team. They are working on several files at the moment and patrolling LSDs and municipalities as much as possible. He explains that an order enforcement file is not a criminal file. Criminal offenses are reported to the RCMP.

7. PRESENTATION – ENGLOBE (Alain Carrier) – Smart Meters

Mr. Alain Carrier works as an electrical engineer for Englobe. In his presentation, Alain tells us about smart meters - the project, the history, the operation. He explains that one of NB Power's mandates is that 40% of its energy resources come from renewable energy. They also want to limit carbon production and emit zero emissions (Net Zero). Since smart meters allow two-way communication (receiving and sending energy to the "grid") they will help achieve this goal. With the arrival of electric cars, the risk of overloading the electricity grid increases, smart meters would allow better management of the grid. Alain explains that each meter communicates by wireless radio signal to a central module that will be installed in the vicinity. The information from each meter is then transmitted to the central system through a fiber optic or cellular network. Information for billing will be received by this smart meter system. The installation will not be imposed on customers and the level of exposure to radio frequencies is confirmed to be below standards. There will be several advantages to the meters: more accurate meters, NB Power will have remote control (to disconnect and reconnect as an example), reduced costs for reading the meters (less labor), faster recovery of breakdowns, a system will notify customers by sending alerts when bills are high compared to previous bills and forecast temperatures, users will be able to access their daily consumption via a web interface, optimization of the voltage levels of the electrical network to name a few. The project is valued at approximately \$ 100 million for the replacement of 360,000 residential and commercial meters. The installation will be carried out in 4 different phases: 1st phase would begin in 2021 with the installation of around 1,000 meters in order to test and set up the necessary infrastructure. The other phases would be in 2022, 2023 and 2024 to replace the rest of the meters. A short question period ensued.

14. NEW BUSINESS

Paul Lang briefly explains the project and what has been done to date.

a. Amish project

WHEREAS in March 2019 the Kent RSC held a forum on agriculture.

WHEREAS participation in the local farmers' forum was unprecedented and participants emphasized the importance of encouraging the industry.

WHEREAS the Kent RSC adopted in 2018 a list of 6 priority initiatives and agriculture was one of these initiatives.

WHEREAS employees of the Kent RSC have started to implement the recommendations that emerged from the forum on agriculture.

WHEREAS among the recommendations is the attraction of new farmers in the region.

WHEREAS the Kent RSC was asked to help a group from the region who is currently working to bring Amish and Mennonite farmers.

WHEREAS the Executive Director met with a group of Amish in November 2019 and the meeting was fruitful.

WHEREAS in order to properly prepare the files necessary to attract these groups of farmers, we must hire a consultant to assess the agricultural land in the region.

WHEREAS ACOA and the Regional Development Corporation are funding XX% of the project to be valued at \$ 35,000.

b. Healthy Community Assessment

Maurice Maillet explains to the members the community health assessment study. A first meeting of the Community Consultation Committee took place yesterday. It is a process of approximately 6 months to assess the community health needs in New Brunswick. Maurice explains that some of the members of the KRSC - Cocagne, Grande-Digue, Notre-Dame, Dundas, Saint-Antoine, Saint-Paul and Sainte-Marie-de-Kent - are part of the community of Shediac / Beaubassin / Saint-Antoine which is a large region. It was the NB Health Council that defined the limitations of these communities. A fear that Maurice expressed at the meeting the previous evening is that several LSDs from KRSC are part of the group which is more in the Westmorland area. And with all the work KRSC is doing collectively in health care, he feels it disconnects us a bit.

Paul Lang explains that the process for changing these limitations is rigid. The CCC has its reasons why these territories were created. These territories are now registered in a provincial regulation under the law on health authorities. So to change the Kent-South region, to the Bouctouche / Richibucto / Saint-Louis territory, it would be necessary to submit a request to the Health Council and to the Minister soon so that they can begin to study the file and make changes so that in 5 years, when the new assessment is made, that it is a single territory. There is no guarantee that if the Kent-South communities wished to opt out of this exercise, that they could join the Bouctouche / St-Louis / Richibucto exercise in the short term. It is therefore more beneficial, at the present time, to continue the current exercise and to start lobbying the Health Council and the Minister to change the boundaries, when there is the next exercise, so that it is a uniform territory and not a territory divided in two. The members agree and wish to request that the territory be uniform for the next exercise.
