# MUNICIPAL ELECTIONS

Municipal elections will take place across the entire Kent region in November. For the first time ever, all residents will be able to vote for representatives to sit on the municipal councils of the six new entities and one rural district that will form the Kent region as of January 2023.

The KRSC Board of Directors will undergo a radical downsizing to 7 members from the current slate of 17 regular members and 3 alternates. The KRSC wishes to acknowledge the exceptional work of the Board to foster development in our beautiful region.

# EXPANDED SERVICE OFFER

The KRSC added two new services in the summer of 2022. Responsibility for social inclusion and community transportation services was transferred in July 2022, which led to the addition of new team members.

Stéphanie Caissie will hold the position of social inclusion and community development coordinator. Her responsibilities will include implementing projects and programs geared to poverty reduction, affordable housing, wellness and the promotion of diversity, as well as initiatives that enhance the lives of Kent residents. Ms. Caissie brings a wealth of experience in socio-economic development.

# THE NEW FACE OF KENT

The Kent region will look very different as of January 2023, with the transition from 27 entities (two towns, four villages, one rural community and 20 local service districts [LSDs]) to six municipal entities and one rural district. Here are the names of the new entities:

**Nouvelle-Arcadie:**

Village of Rogersville and LSDs of Collette, Acadieville and Rogersville

**Beaurivage:**

Village of Saint-Louis-de-Kent, Town of Richibucto, and LSDs of Saint-Louis, Saint-Ignace, Aldouane and Saint-Charles

**Five Rivers:**

Village of Rexton and LSDs of Richibucto, Weldford and Harcourt

**Grand-Bouctouche:**

Town of Bouctouche and LSDs of Wellington and Sainte-Anne-de-Kent

**Champdoré:**

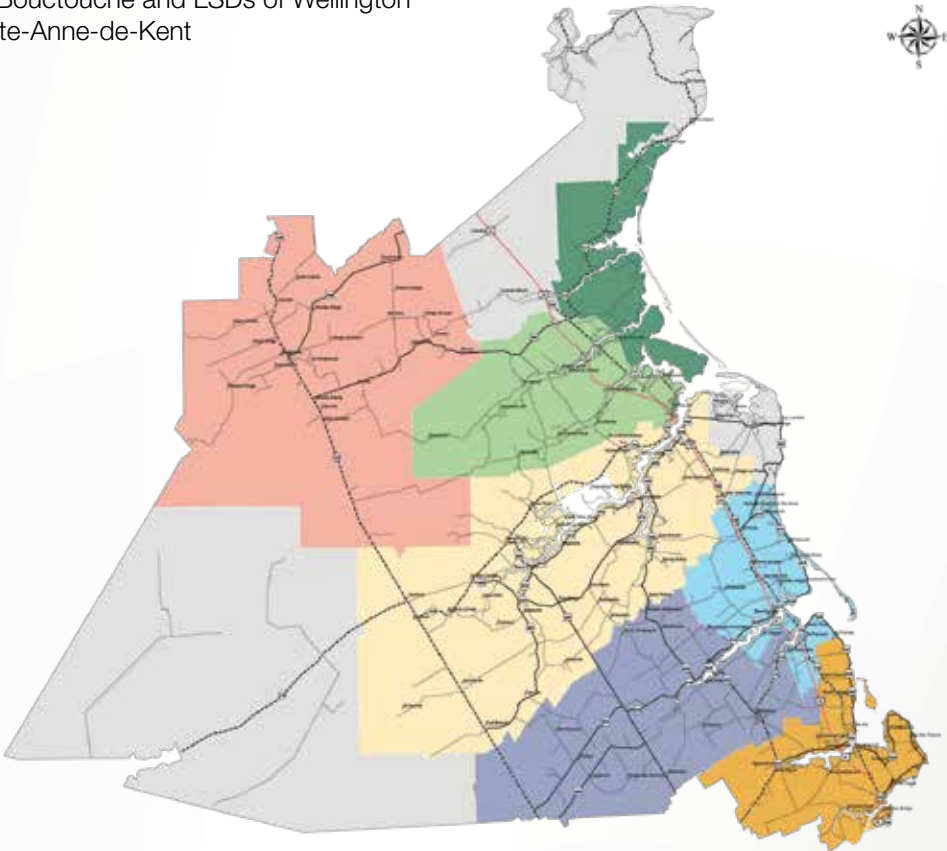
Village of Saint-Antoine and LSDs of Sainte-Marie, Saint-Paul and Grand Saint-Antoine

**Beausoleil:**

Rural Community of Cocagne and LSDs of Grande-Digue, Dundas and Shediac Bridge-Shediac River

LSDs of Carleton, Pointe-Sapin, Baie Sainte-Anne, Hardwicke, Escuminac, Cap-de-Richibouctou and part of Harcourt

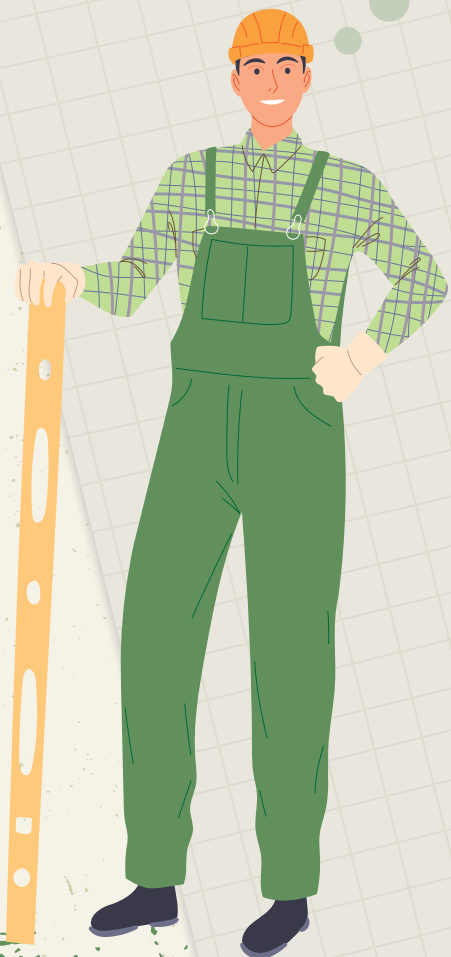

**The KRSC Board and staff congratulate Ms. Ringuette on her appointment and wish her a warm welcome to the organization!**

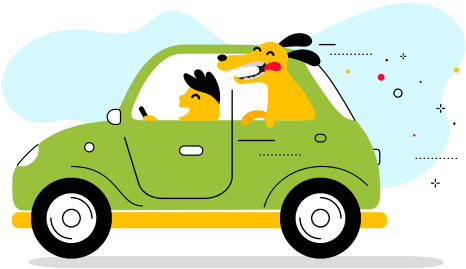


## Recreation Master Plan

## WE ACCEPT THE FOLLOWING ITEMS:

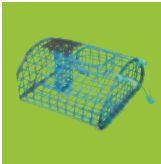
Maximum quantity equivalent to a half-ton truck or utility trailer load.  
*Residents are asked to sort their load by type of material to facilitate unloading.*



Household hazardous waste



Glass and cardboard (this material will be recycled)



Marine debris (limit of 5 traps and 10 buoys per resident)



Appliances and furniture



Construction and demolition waste (make sure it's easy and safe to transport)



Tires (limit of 8 per resident)



Ash



And more!



Automotive parts (except tires)



Unsorted waste



Regular waste eligible for roadside pick-up (blue, green and clear bags)

# IMPORTANT CHANGES COMING IN 2023

## Solid Waste

Delays in bulky waste collection over the past year have led us to rethink the delivery of this essential service. We will be implementing a completely new model starting in 2023.

More frequent on-demand collection of smaller quantities will ensure more consistent service.

**STARTING APRIL 2023,**  
bulky waste will be collected  
in the following way:

Service by **registration**: over the phone,  
on our website or on the “Kent Ser-  
vices” mobile app

**Residential collection every six weeks\***

**Each region will conduct eight  
collections per year (six in 2023)**

**Six bulky items will be accepted at a  
time (up to 48 per year)**

\*There will be no collection during the holiday  
season or Acadian Day festivities.



## Guidelines

- Collection of bulky items, not large quantities of waste
- Maximum of six items at a time
- Small quantities of lumber and other building materials will be accepted provided they are grouped in bundles measuring 4 ft x 2 ft x 2 ft (1.2 m x 0.6 m x 0.6 m) and weighing no more than 50 lb (23 kg).
- No black or opaque bags
- No waste in trailers or truck boxes
- No hazardous waste, car parts or commercial waste

**Bulky waste collection remains unchanged for fall 2022.

The territory of Kent will be divided into six (6) regions which are not yet determined. More details will follow by the spring of 2023.
