5. TENDERS – WASTE COLLECTION CONTRACT

Contract attribution for the collection of residential solid waste: K1 collection Territory.

WHEREAS the Board of Directors of the Kent Regional Service Commission Kent adopted the 2015-065 motion to move forward with the optimized collection system;

WHEREAS the Commission received the approval of the participating communities in the optimized collection system through the 2015-066 motion;

WHEREAS the estimated annual cost for the collection of residential solid waste is \$1,746,047 and is included in the 2021 budget of the Commission;

WHEREAS the Commission launched the call for tenders for the K1 collection territory on September 25th for the intended services;

WHEREAS a total of four (4) proposals were received for the call for tenders # 2020-09-25-K1;

WHEREAS two (2) proposals had to be rejected because they did not comply with the mandatory requirements in the call for tenders # 2020-09-25-K1.

Here are the selected proposals:

Fero Waste & Recycling Inc. for the sum of \$2,281,577.23 for four (4) years excluding HST:

- \$522,525.73 for year one (1) of the contract
- \$574,778.30 for year two (2) of the contract
- \$586,273.86 for year three (3) of the contract
- \$597,999.34 for year four (4) of the contract

Miller Waste Systems Inc. for the sum of \$2,843,054.08 for four (4) years excluding HST:

- \$645,358.01 for year one (1) of the contract
- \$718,107.46 for year two (2) of the contract

10. MONITEUR ACADIEN – SUPPORT

Paul Lang explains that since the Étoile Kent no longer exists, they have approached the Moniteur Acadien to find out if they could expand their distribution in Kent. The owner, Bernard Richard, is interested but a feasibility study will have to take place before making a final decision.

11. LOCAL GOVERNANCE REFORM

Pierrette Robichaud announces that there will be changes to the Local Governance Reform. Consultations will take place and it will be necessary to ensure that the KRSC is involved. A consultation will take place with the Minister in the near future.

12. NEW BUSINESS

a) Immigration

Pierrette brings an information point to the group regarding immigration to our rural areas. She mentions that in our rural areas we have a big labor shortage that is not going to be solved overnight. Currently, we have an immigration satellite office in Richibucto / Bouctouche under MAGMA Moncton. In the South East there is a satellite immigration office which is under the CAFI. Having two immigration agencies seems to slow us down in the immigration process in our rural areas. South East and Kent are working on different files together but one is part of CAFI while the other is part of MAGMA. And it is certain that MAGMA and CAFI in Moncton do not have the same vision towards immigration as in our rural areas. That's why we're working with these two groups to see if we could merge the two regions and have our own immigration office. The group will be kept informed of the file.

b) Conservation zones

A report has been submitted for the West side of Route 126. Minister Holland would like to join us in giving a presentation in November or December.
