a. Planning

The minutes of the February 17th, March 15th and April 19th, 2021 Planning Review Advisory Committee meetings and the construction report for May 2021 were circulated.

Cloudpermit

WHEREAS the management personnel has been actively pursuing an electronic program for the issuance of building and development permits since 2018.

WHEREAS the first initiative with a local company failed in 2020. (GARAGO)

WHEREAS we have discovered a company that specializes in the field with several towns, villages and service areas to its credit.

WHEREAS several regions in Canada are currently under contract with Cloudpermit.

WHEREAS KRSC recognizes the importance of being environmentally friendly by reducing the use of paper. WHEREAS our employees will benefit from an electronic permit system regardless of their geographical location

WHEREAS the automatic numbering of permits and the ease of reporting will benefit the administrative staff.

WHEREAS the annual cost of the permit module is \$18,000 plus taxes per year for 5 years.

WHEREAS there will be a one-time setup fee of \$5,000 plus taxes, including employee training.
