5. IMPERIAL KENT NORTH CENTER AGREEMENT

a. Motion do *repeal* the agreement for the Imperial Kent North Center

WHEREAS a cost-sharing agreement for general operations of the Imperial Kent North Center was concluded in 2018 between the Town of Richibucto and the Kent RSC, with the Village de Saint-Louis-de-Kent, the Village of Rexton and the Local Service Districts of Pointe-Sapin, Carleton, Saint-Louis, Saint-Ignace, Aldouane, Saint-Charles, Richibucto, Cap-de-Richibucto and of Weldford;

WHEREAS in anticipation of the commencement of *An Act Respecting Local Governance Reform, 2022* (S.N.B. 2022, c. 31) and the directives issued from the Department of Environment and Local Government, the current cost-sharing agreement for the sub-regional recreation facility, the Imperial Kent North Center, must be repealed;

WHEREAS the boundaries of the new entity of the Town of Beaurivage effective January 1, 2023 will have an impact on the allocation of operating costs between the sub-regional entities of the Village of Five Rivers and the Kent Rural District, and also within the new entity of the Town of Beaurivage;

WHEREAS the repeal of the current agreement is conditional upon the adoption of the new agreement.

Be it therefore resolved that the Board of Directors of the Kent RSC request that the cost-sharing agreement for general operations of the Imperial Kent North Center be repealed in order to allow for the adoption of a new agreement.

b. Motion to *adopt* the new agreement for the Imperial Kent North Center

WHEREAS a cost-sharing agreement for general operations of the Imperial Kent North Center was already in effect since 2018 between the Town of Richibucto and the Kent RSC, with the Village de Saint-Louis-de-Kent, the Village of Rexton and the Local Service Districts of Pointe-Sapin, Carleton, Saint-Louis, Saint-Ignace, Aldouane, Saint-Charles, Richibucto, Cap-de-Richibucto and of Weldford;

WHEREAS the 2018 agreement has been conditionally repealed to allow for this agreement to be concluded in anticipation of the commencement of *An Act Respecting Local Governance Reform, 2022* (S.N.B. 2022, c. 31) and the directives issued from the Department of Environment and Local Government. WHEREAS, the general basis of the previous agreement has been retained;

WHEREAS the Town of Richibucto will continue to provide recreational services at its sub-regional recreation facility, commonly known as Imperial Kent North Center, for the benefit of the residents of the local governments and the local service districts in its vicinity;

WHEREAS the Town of Richibucto agrees to continue to ensure the management of the facility and to be accountable to the communities contributing financially to the facility;

WHEREAS the Town of Richibucto is willing to enter into this new cost-sharing agreement that would include oversight provided through the communities contributing financially to the facility;

WHEREAS the responsibilities of the Town of Richibucto, the Imperial Kent North Advisory Committee and the Kent RSC have been adapted to respect the new local government structures and taxing authorities of the former local service districts as a result of the reform, effective January 1, 2023;

WHEREAS the Kent Regional Service Commission remain responsible for facilitating and enforcing this agreement;

WHEREAS at the time of the conclusion of the current agreement, the residents of the former participating local service districts listed in Schedule A of the new agreement, and the Village of Rexton expressed to

the Minister their desire to have access to and use of the sub-regional recreation facility and their willingness to pay the Town of Richibucto for such access and use by their residents;

WHEREAS the fixed tax rates for each of the local governments and taxing authorities concerned by this agreement remain the same as in the previous agreement;

WHEREAS the Town of Richibucto remains financially responsible for the debentures and related capital costs;

WHEREAS this cost sharing agreement will be in effect from January 1st, 2023 to December 31st, 2028, inclusive.

Be it therefore resolved that the Board of Directors of the Kent RSC adopt and sign a 5-year agreement with the Town of Richibucto.

6. REDISTRIBUTION OF ELECTORAL BOUNDARIES

a. Provincial Electoral Boundaries Commission

WHEREAS the readjustment of provincial electoral boundaries is done every 10 years in New Brunswick; WHEREAS the electoral quotient selected by the Provincial Electoral Boundaries Commission is 11,714 voters;

WHEREAS the Kent region had an increase in population during the last census and this could justify the addition of an electoral district in the Kent territory;

WHEREAS the proposal submitted follows the geographic boundaries of the Kent RSC.
