#### c. Bylaw Enforcement Officer contract

WHEREAS the amount in 2023 is already in the budget and has been adopted by the Minister;

WHEREAS Maritime Enforcement Services has proposed a 2-year agreement rather than one and the amount in 2024 will be \$57,500;

WHEREAS the services of Maritime Enforcement Services greatly assist the KRSC Planning Department and the municipalities in complying with zoning by-laws, land use planning and ensuring that citizens have a building permit.

WHEREAS the composition of the Recreation, Sport and Culture Committee has been adjusted in accordance with the New Brunswick Regulation 2022-84 under the *Regional Service Delivery Act* (O.C. 2022-317);

WHEREAS the composition of the Recreation, Sport and Culture Committee has also been modified to allow a greater representation of the sector and the region;

WHEREAS the Terms of Reference of the Recreation, Sport and Culture Committee be amended to reflect the above.
