10. REPORTS ON COLLABORATIVE SERVICES ACTIVITIES

a. Planning

The minutes of the Planning Review Advisory Committee meeting of May 30th, June 27th and July 25th, 2023, as well as the construction report for August 2023, are circulated.

b. Solid Waste

The committee met on September 21st, 2023 and the minutes will be circulated at a later date. The solid waste report for August is circulated.

c. Public Safety

The minutes of the March 9th, 2023 and June 14th, 2023 Public Safety Committee meetings are circulated. The committee also met on September 14th. Minutes will be circulated after approval.

Paul Lang reports on the Public Safety Day held at the Municipality of Five Rivers on Saturday, September 23rd. There was a very good turnout.

d. Economic Development

Marie-Paul Robichaud gives a brief update on what's happening with Economic Development in the region.

In his presentation, Jonathan Keeley from Vivify discusses the mandate for creative and marketing services for the Kent Regional Service Commission, in addition to the 3 themes (recruitment, communication with residents, tourism promotion) and the 2 phases of the project. He explains the process - strategy, creation, deployment and feedback. He focuses on Phase 1 (2023), which is to create a platform on the website to promote the Kent region. In this first phase, profiles of municipalities and available services would be created to inform people about housing, education, health services, transportation, jobs, childcare and possible activities in the region. There will also be the preparation of documentation (tools, pamphlets, maps, etc.) to, for example, support presentations in partnership with Vitalité, which recruits in health needs. Phase 2 (2024) will be based on the results of Phase 1, with adjustments made as required. In addition, we will be able to use the tools and promotion for tourism. Phase 2 will be more focused on residents, especially in terms of communication. With the amalgamations and changes with solid waste, this will support residents in this transition.

WHEREAS the Kent Regional Service Commission has been mandated to work on the economic development in the region;

WHEREAS the Kent Regional Service Commission has created an economic development committee and a labor market forum made up of elected officials and business people;

WHEREAS the Kent Regional Service Commission has a strategic plan and the attractiveness of our region as well as our businesses to identify and mobilize new workers is a concrete objective;

WHEREAS the Economic Development Committee / Forum recommends a recruitment and retention strategy.

Marie-Paul Robichaud advises the group that IRC (Immigration Refugee Canada) would like to give presentations to entrepreneurs in the region on November 30th or December 1st. Possibly one presentation in Cocagne and one in Saint-Louis-de-Kent, to make the sessions accessible to all those who would like to participate. There would also be a virtual follow-up in January for people who have questions, would like to participate in the process, etc.

e. Tourism Promotion

A tourism forum was held on September 27th and 28th, 2023, with some twenty participants from Port Elgin to Kouchibougouac. The discussions were very interesting, and it's clear that everyone shares the same concerns. The Akadi Lumina project in Pays de la Sagouine has been a great success. To date, 31,000 people have visited the site. However, the restaurants are no longer open after 7pm, and the AirB&Bs have all been rented out since the previous year, so there's a lot of work to be done to rebuild and attract tourism to our region.

f. Community Development

g. Regional Transportation

At their last meeting a few weeks ago, the committee focused on the development of a transportation policy, since nothing had been established since the transfer in July 2022. The General Policy, 23-04 – Regional Transportation Services, is circulated.
