7. PRESENTATION - Ginette Doiron (Destination Southeast) and Jonathan Keeley (Vivify) — Activity report

Ginette Doiron of Destination Southeast and Jonathan Keeley of Vivify present the group with their marketing objectives in relation to Destination Southeast. They talk about the 2023 campaign and what's to come in 2024. Among other things, they talk about digital advertising, organic publications on social networks, the creation of organic videos, billboard advertising, blog creation and more. They also talk about events that have taken place, such as the cultural market, the tourism forum, the Saltscapes Halifax exhibition and the Salon du VR Québec. The activity report for 2023 shows financial partners, municipalities, various meetings with partners and member support. In 2024, they will focus on developing a digital advertising campaign, collaborating with organic partners, developing a tourist guide, developing a series of contents for off-season activities, promotional items and workshops, a calendar of events and maps to promote our region.

a. Finances – Administration – Human Resources

Lynn Landry Caissie presents the unedited financial statements for December 31st, 2023 and provides explanations.

b. Audit

The audit will begin in March, and the results will be presented at the AGM in April.

c. Health

Aldéo Saulnier explains that a number of things have been happening lately and that they have had several meetings about health in Kent. Paul Lang speaks about the meeting held with Vitalité on February 13th, 2024. There were three items on the agenda - 1. Communication - will be rectified in the future; 2. Closure of acute care beds at Stella-Maris-de-Kent Hospital - details still to be clarified and 3. Infrastructure. Vitalité will develop a capital plan for the facility, and the community will be part of the process. The process should begin in the next few months, and members will be kept informed of any developments. At the meeting, the CEO confirmed that Vitalité has no intention of closing or converting the hospital to another vocation, and that emergency services will continue at the institution. Some members of the

Health Committee met this morning to discuss Tuesday's meeting and would like clarification and details about acute care.

WHEREAS the Chair of the Kent Regional Service Commission (KRSC), the Chair of the KRSC Health Committee, the Executive Director of the KRSC and the Chair of the Stella-Maris-de-Kent Hospital Foundation met with the Vitalité Health Network on Tuesday, February 13th, 2024;

WHEREAS the meeting held on February 13th was very positive and there is a mutual willingness to collaborate between the Vitalité network and the KRSC to improve healthcare in the Kent region;

WHEREAS the Vitalité Health Network has communicated that it has no intention of changing the vocation of the Stella-Maris-de-Kent Hospital;

WHEREAS the Vitalité Health Network wishes to improve primary health care in the region;

WHEREAS the elected officials of the Kent region wish to receive the Vitalité Health Network's plan to bring acute care hospital beds back to the Stella-Maris-de-Kent Hospital.

Optimized collection system

WHEREAS the optimized collection system was unanimously adopted by the Board of Directors of the Kent Regional Service Commission (KRSC) on May 21st, 2015;

WHEREAS the regions of Baie-Sainte-Anne, Escuminac, Hardwicke, Shediac-Bridge, Shediac-River and the Notre-Dame section of Westmorland County were inserted into the territory of the KRSC in January 2023 by the local governance reform;

WHEREAS the collection contracts in these territories are managed by the Province of New Brunswick and will expire on November 3rd, 2024;

WHEREAS if the municipal council of the Rural Community of Beausoleil wishes to transfer all responsibilities related to the collection of residential solid waste in its new territory to the KRSC, they must do so by the same date;

WHEREAS the addition of communities to the optimized collection system on this date requires the dissolution of two existing collection contracts (K1 and K5) and the creation of new contracts;

WHEREAS the sharing of collection costs is based on the percentage of households from the different communities of the Kent region and that the addition of a community will have an impact on the distribution of costs:

WHEREAS the sharing of tipping fees is based on the percentage of population from each community in the Kent region for the total tonnage produced and that the addition of a community will have an impact on the distribution of costs;

WHEREAS Calls for Tenders will be prepared and published by the KRSC during the month of July 2024.

It is therefore resolved that the Kent Regional Service Commission's Board of Directors accepts the extension of the optimized collection system to the communities of Baie-Sainte-Anne, Escuminac, Hardwicke, Shediac-Bridge, Shediac-River, and the Notre-Dame section of Westmorland County as of November 3rd, 2024, on condition that the respective authorities transfer us the responsibility.

This morning saw the launch of the Youth Planet project, which was a great success with students from MFR, Bonar Law and Clément-Cormier schools taking part.

e. Tourism Promotion

f. Community Development

With the Regional Strategy, it was proposed to implement a new program to help young people participate in recreational, sporting and cultural activities, which is a great need in Kent. In order to create and implement this program, Carolle Maillet has been hired to help with the project. Carolle will also participate in the Physical Literacy for Communities project to build new programs and provide opportunities to get young people moving. Claudie announced that funding requests had been made in collaboration with Stéphanie Caissie of Community Development and Chanelle DaPonte of Kent Resiliency, and that since yesterday, four pieces of good news have been announced:

- \$25,000 was received for a project called New Horizons for Seniors. It's an Amazing Race type project, which has been done elsewhere in the province and has worked very well. It's a kind of scavenger hunt, and the aim is to showcase the Kent region through an intergenerational project.
- ❖ The Economic and Social Inclusion Corporation (ESIC) is donating \$11,000 for "play boxes". These are iron boxes containing items for sports games (soccer balls, tennis rackets, basketballs, skipping ropes). The aim is to give young people access to outdoor activities that are fun and get them moving. This does not replace existing library programs that offer equipment loans. Rather, it's intended to target those areas of Kent most remote from the municipalities.
- ❖ A third piece of good news is that Stéphanie Caissie, with the help of Mario Doiron, Food Resilience Coordinator, has received \$17,000 to upgrade or replace equipment for breakfast programs in the region's schools.
- ❖ And finally, for the "I'm committed to my mental health and well-being" initiative, \$6,000 was received to work with the Resiliency Committee to create a wellness and mental health forum with our partners.

g. Regional Transportation

The transport service now has 27 drivers and over 600 customers in the region who use our services. The search for drivers continues. One challenge we face is with people who have to go to dialysis on a regular basis. Various options are being examined to cater for this clientele. This is something that was briefly discussed with Vitalité at the February 13th meeting, and they were receptive.
