6. BUSINESS ARISING FROM THE MINUTES

a. RSC study - Message from the MELG

Paul Lang indicated that the Department of Local Government is planning to launch a study on the RSCs in the near future. Although consultants have not yet been hired, their recruitment is expected soon. In the coming months, consultations will be held with members of the Board as well as representatives from rural districts, as the study concerns them as well. The purpose of this initiative is to assess how RSCs can enhance their services and improve governance. The consultants will submit a report to the department in time for the spring session of the Legislative Assembly. This report may include recommendations with potential legislative impacts. Paul will keep members informed as the file progresses.

7. PRESENTATIONS

a. Presentation on racism (Phylomène Zangio)

Ms. Phylomène Zangio gave a presentation to the group on the topic of racism and discrimination. She proposed various ways for municipalities and the Kent RSC to get involved and actively contribute to addressing these issues, emphasizing the importance of "building bridges" between communities to foster better understanding and coexistence. She also spoke about the Karibu Project, an initiative supported by the Kent Regional Service Commission and led by the New Brunswick Provincial Council of People of African Descent. The project aims to promote the rights, inclusion, and recognition of Afro-descendant communities in the province. Furthermore, Ms. Zangio encouraged municipalities to join the Canadian Coalition of Municipalities Against Racism and Discrimination. This network of cities and municipalities shares experiences and best practices to improve local policies in the fight against racism, discrimination, exclusion, and intolerance. Membership offers several benefits, including access to tools, resources, workshops, and opportunities to engage with other member municipalities. She stressed the need to take concrete action at the local level.

b. Presentation of the report on food resilience (Maurice Maillet)

Mr. Maurice Maillet, consultant, presented the report on food resilience, which addresses issues related to food insecurity, social inclusion, and both community and economic development. He outlined the project's vision: to ensure equitable access to healthy food for all. He then reviewed the strategic objectives, structured around five key intervention priorities. He also presented the action plan, highlighting the roles of various partners and the resources involved. Finally, he went over the expected results, providing explanations for each.

10. REPORTS ON COLLABORATIVE SERVICES ACTIVITIES

a. Planning

The minutes of the Planning Review Committee of May 27, June 24 and July 29, 2025 as well as the construction report for August 2025 were circulated.

b. Solid Waste

The minutes of the Solid Waste Management Technical Committee dated May 22, 2025, and the August 2025 solid waste report have been circulated.

Optimized collection system – Saint-Antoine

Isabelle explains that contact has been made with the two collection companies to begin negotiations for the extension year in the K2, K3, K4 and K6 contracts. One of the companies agreed to a meeting on Friday, September 12th, to discuss this matter. During this meeting, the discussion switched on the clauses allowing for early termination of the contract.

A written correspondence was received confirming that McAction Enterprises Inc. is invoking the 90-day clause in its contract, which means that the operations provided for in the K4 contract will end on Saturday December 13, 2025. The administration has therefore prepared a call for tenders, which will be issued as early as tomorrow, Friday, September 19, to find a company to provide collection services in this territory.

This company also provided residential waste collection services in the former village of Saint-Antoine. Consequently, a request has been received from the Town of Champdorée for this territory to join the

optimized collection system as of December 14, 2025. Isabelle points out that adding this territory to her call for tenders won't cause any problems for the administration.

WHEREAS the optimized collection system was unanimously adopted by the Board of Directors (the Board) of the Kent Regional Service Commission (KRSC) on May 21, 2015;

WHEREAS the municipalities of Bouctouche and Saint-Antoine did not join the optimized collection system in 2015, but Bouctouche voted unanimously to join the optimized collection system in 2022;

WHEREAS the 90-day clause has been invoked for the K4 contract and, as a result, the KRSC must issue a call for tenders for this contract as soon as possible;

WHEREAS the municipal council of Champdoré voted unanimously for the territory of the former Village of Saint-Antoine to join the optimized collection system on December 14, 2025, ensuring that its entire territory is covered by the KRSC's collection contracts (see correspondence);

WHEREAS, by joining the optimized collection system, the territory of the former Village of Saint-Antoine will be served by the KRSC for weekly residential waste collection as well as bulky waste collection;

WHEREAS the K4 contract is currently a three (3) day weekly collection contract allowing for the addition of the former territory of Saint-Antoine to the call for tenders;

WHEREAS the collection of bulky waste in the former Village of Saint-Antoine will be added to the K6 contract as permitted by clause 3.22 thereof;

WHEREAS the sharing of collection costs will be based on the percentage of residences in the various communities in the Greater Kent Region, and the addition of a community will have an impact on the distribution of costs;

WHEREAS the sharing of unloading costs will be based on the percentage of population of the various communities in the Greater Kent Region for the total tonnage produced, and the addition of a community will have an impact on the distribution of costs.

Adoption of the 2025 Regional Food Resilience Strategy

WHEREAS the KRSC issued a request for proposals by invitation on November 29, 2024, to initiate the development of a Regional Food Resilience Strategy;

WHEREAS the proposal submitted by consultant Maurice Maillet was selected by the KRSC Board of Directors, in accordance with resolution 2025-004, to carry out the food resilience strategy;

WHEREAS the development of the strategy began in February 2025, including a literature and data review, an online survey, as well as public and targeted consultations with key sectors, with the aim of analyzing the current food situation in the region;

WHEREAS an ad hoc advisory committee was formed, allowing all its members to provide comments and feedback throughout the process, notably on the intervention areas recommended by the consultant;

WHEREAS the strategy presented by consultant Maurice Maillet provides a guiding framework for KRSC's food resilience initiatives, and also serves to guide KRSC and its partners in a collaborative approach toward concrete, feasible, and sustainable actions aimed at improving the food resilience of our communities;

WHEREAS an implementation plan will be developed internally and in collaboration with Maurice Maillet following the adoption of the strategy;

WHEREAS according to resolution **2025-009CD**, the Social Inclusion and Community Development Committee has acknowledged receipt of the regional food resilience strategy report, prepared by consultant Maurice Maillet, and recommends that the KRSC's Board of Directors adopt said strategy at its regular meeting on September 18, 2025.
